3. COMPOSITION/INFORMATION ON INGREDIENTS

Frozen human cells in a mixture of hazardous and non-hazardous components. Specific chemical identity and percentage of composition are withheld to protect confidentiality. Cells are shipped in fetal bovine serum (FBS) and 5- 10% dimethyl sulfoxide (CAS # 0000067-68-5). This mixture contains no ingredients at concentrations considered to be hazardous as defined by OSHA HCS 2012 but should be handled according to good lab practices.
